


108,699 Physical Items and 27,985 Digital Items were circulated by the Library—The Friends and Foundation annually donate \$40,000 to the Library Book Fund for new books, audio books, magazines and other materials.




Five Local History Events attended by 275 patrons / Digitization of Local History Archives—\$15,000 dispersed from a multi-year \$75,000 donation made by David Laws in memory of Jean Laws for The Laws Family Room; \$6,731 dispersed from donations made in 2021 to inventory, catalog and digitize the Library's local history collection to improve and increase public access.

440 Youth Programs attended by 11,570 Children and Teens—\$9,431 donated for Summer Reading and other Youth Programs through the Joe Rock Fund (CFMC Youth Services Fund) plus \$2,859 donated from two past Monterey County Gives! grants for Bilingual Storytime and Summer Reading in the Park.

Monterey County Gives!—\$41,838 presented to the Library in August 2022 for the Mobile Outreach Vehicle electric (MOVE) from 2021 campaign; \$37,805 raised during 2022 campaign for Teens Thrive at the Library.

National Poetry Month and Fall Series Programs attended by 605 patrons—Sponsorship of National Poetry Month speakers and events in April, 2022 and the *Renaissance: Remember, Rise and Revitalize* Fall Series, including a juried art exhibit and poetry, music and dance events.



Book Store, Dine Out, and Buy A Book on the Library's Quilt—\$25,206 raised for the Library, including \$17,601 from Book Store sales, \$2,364 from Dine Out donations, \$4,765 from the Buy A Book campaign and \$476 from donations at events.



Volunteers—112 Friends and Foundation volunteers support Library events throughout the year, Monday-Friday shifts at the Friends & Foundation Book Store and First Saturday Book Sales; help maintain the Library garden; support a lending library at The Meals on Wheels Community Center; manage the Dine Out program; publish and distribute our newsletter; maintain our website and social media sites; coordinate the Friends Book Club; and serve as Board members.
